Ballot Measure Recommendations for the November 2025 General Election

## Lake Forest Park Proposition 1

## Yes on Proposition 1

The City of Lake Forest Park is obligated to provide public safety services to residents, including police service, 911 dispatch, prosecutor and public defense, and mental health crisis support. Costs for these services have increased steadily due to a combination of improved services and inflation. However, the City's property taxes- the primary funding source for these services- have not kept pace. We agree that our communities should, when possible, look to their own residents to fund their public safety needs. We also agree that increasing the property tax is the least regressive option available to Lake Forest Park residents. Proposition 1 proposes increasing the City's portion of property taxes by \$0.24 per \$1,000 of assessed property value for 6 years to provide a dedicated revenue stream for public safety. The proposal includes exemptions for qualifying seniors, disabled veterans, and others with disabilities. We urge the Lake Forest Park community to responsibly fund their agreed services by approving Proposition 1.

## **King County Council**

**Executive: Dual Endorsement** 

#### **Girmay Zahilay**
